This Foster Care Agreement is entered between The Haven No-Kill Animal Shelter, a non-profit corporation, and the undersigned (the approved "Caretaker" or "you") In consideration of the mutual promises in this Agreement, and other good and valuable consideration, The Haven and Caretaker agree to the following terms and conditions, intending to be legally bound:

1. **Foster Care.** You will provide the foster care in your home at the address at the end of this Agreement, in an area segregated from your own pets and from any other animals you may be fostering, subject to the terms and conditions of this Agreement. Your Foster Care for the animals will be comprised of the following:
 - Providing daily feeding of food and water.
 - Provide outdoor exercise for dogs for elimination within a fenced in yard or on a leash.
 - Provide a warm safe place for animal
 - Administering medicines, if any
 - Transport animal to veterinarian, if necessary
 - Socializing, playing, and _____

The maximum number of foster animals allowed in and around your home during the Foster Care period is six.

2. **Veterinary Care.** Whenever needed you will use the usual veterinarian for The Haven animals:

You will telephone the Director at 251-370-4267 to advise him of any emergencies involving the foster animals for The Haven, for pre-approval on emergency vet-care, and also email The Haven on a weekly basis to advise the adoption coordinator on how the animals are. 3. **Costs and Expenses.** The Haven will pay for all veterinary treatment costs that may be incurred for the foster animals during the Foster Care; provided, that we have given you prior approval by telephone or email for such treatments. You will give us any receipts/invoices from the veterinarian for the veterinary care and medicines. You are providing the Foster Care out of your love for animals, and as a volunteer; at no charge to The Haven.
4. **No Liability.** The Haven is not liable for any bodily injury or property damage, losses or injuries whatsoever to you or other persons, or to your or another person's animals and pets, caused by the actions, behavior or health of the animals, or arising out of the Foster Care.
5. **Vaccinations.** We represent that, except for puppies and kittens under six weeks of age are currently:
 - Dewormed
 - Vaccinated for rabies (12 weeks and older)
 - Canines are vaccinated with DHLPP or DAPP
 - Felines are vaccinated with FVRCP
 - Spayed/Neutered
 - Micro-chipped

If the Foster Care animal is not altered before entering into your home, arrangements will be made in advance with a partnering veterinarian. You agree to bring the Foster Care animal to approved scheduled appointment.

6. **Returning Foster Care Animals.** You agree to contact us immediately by telephone or email in the event that you are no longer able or willing to provide Foster Care to any or all of the animals in your care. You agree to continue to care for all of the Foster Care for a reasonable period until we are able to accommodate these animals into another foster home or at the shelter. The Haven does not give any specific timelines for this action. We will notify you by telephone whenever we have an reasonable opportunity to take in the Foster Care animals, whether for adoption into a permanent home or any other reason. You will cooperate with us by promptly arranging a mutually satisfactory time for us to receive any Foster Care animals being returned. You may not entrust the care of the animals to any other person or relocate them.
7. **Adoption by Caretaker.** In the event that you wish to adopt any of the animals as a household pet for yourself, you must first enter into our Adoption Agreement, and if the animal is not yet sterilized, also enter into our "Sterilization Policy."
8. **Entire Agreement; Modifications; Binding Effect.** This Agreement is the entire Agreement between you and The Haven. Any modification to the Agreement must be in writing, signed by both you and The Haven. This Agreement binds your and our respective heirs, executors, representatives, successors and assigns.
